ALASKA	NOTARIZATION NOT REQUIRED
ARIZONA	NOTARY'S SIGNATURE, SEAL IMPRESSION OR STAMP, AND DATE COMMISSION EXPIRES. AN EMBOSSEMENT SEAL MAY ONLY BE USED IF THE RUBBER STAMP SEAL IS USED. AN EMBOSSEMENT SEAL MAY NOT BE USED ALONE.

OKLAHOMA	SIGNATURE OF NOTARY PUBLIC, DATE COMMISSION EXPIRES, DATE OF NOTARIZATION
OREGON	NOTARIZATION NOT REQUIRED
STATE	NOTARY PUBLIC REQUIREMENTS FOR TITLE DOCUMENTS (TITLE OR MCO)
PENNSYLVANIA	INKED STAMP, SIGNATURE OF NOTARY PUBLIC, DATE OF NOTARIZATION AND DATE COMMISSION EXPIRES. AN EMBOSSING SEAL MAY BE USED AT THE NOTARY'S DISCRETION OR AT THE REQUEST OF THE CLIENT. THE VEHICLE CODE PERMITS VERIFICATION OF A PERSON'S SIGNATURE IN LIEU OF NOTARIZATION ON ANY DOCUMENT REQUIRED TO BE SUBMITTED WITH AN APPLICATION FOR A CERTIFICATE OF TITLE. EMPLOYEES OF AN ISSUING AGENT OR WHOLESALE VEHICLE AUCTION NAME WITH AN 85, 86, OR 87 DIN AND LICENSED BY THE STATE BOARD OF VEHICLE MANUFACTURERS, DEALERS, AND SALESPERSONS, ARE QUALIFIED TO VERIFY A SIGNATURE ON A MOTOR VEHICLE FORM IN LIEU OF NOTARIZATION.
